AN ORDINANCE introduced by Interim City Manager Doug Gerber, concerning carrying of firearms in City-owned buildings, repealing City of Topeka Code § 9.40.005.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF TOPEKA, KANSAS:

Section 1. That section 9.40.005, Unlawful carrying, of The Code of the City of Topeka, Kansas, is hereby repealed.

~~(a) — It shall be unlawful for any person, except those persons exempted under K.S.A. 21-4201(b), as amended, or security personnel authorized by the city manager, to carry any firearm in any of the following buildings or facilities owned and operated by the city:~~
