Dear Mr. Wilburn:

With great enthusiasm, I support the community effort to recognize the crucial role Nick Chiles played in the historical development of Topeka. Born in South Carolina's African American community of Abbeyville in 1867, Mr. Chiles received his formal education in Greenville, South Carolina. By 1886, he and his wife had moved to Topeka, Kansas, where his uncles settled years earlier.

At a time when laws and overt practices of racial segregation and discrimination were enforced throughout the United States, especially in the South, Mr. Chiles seized economic and political opportunities for advancement in Kansas by establishing a variety of small business enterprises and becoming an active member of the state's Republican Party. In 1899, he founded the Topeka \*\*Plaindealer\*\* weekly newspaper, serving as its manager and editor. Due to his fervent push for racial uplift through self-help activities and desire to have Kansas serve as a beacon for freedom and equality for all peoples, Mr. Chiles's business acumen enabled the \*\*Plaindealer\*\* to enjoy the largest circulation of any African American newspaper west of the Mississippi. He also served as president of the Western Negro Press Association in 1904.

As a native Topekan, I first learned about Mr. Chiles from my father, who spoke of my maternal grandfather's friendship with Mr. Chiles and revered Mr. Chiles as a prominent Topeka civic leader. Among scholars and other researchers in African American history, Mr. Chiles is well known. For example, last year a graduate student in history from Baylor University traveled from Texas to our archives to explore our African American Experience Collections for his dissertation study on life in Topeka during the era of Nick Chiles and the **Plaindealer**.

Indeed, Mr. Nick Chiles and his Topeka *Plaindealer* enhanced the growth of Topeka during the early 20<sup>th</sup> century.

## To The Governing Body:

I am writing to show my support for Delbert Wilburn's proposal for the renaming of 10<sup>th</sup> Street Bridge located at Banner to the Nick Chiles Bridge. I am the Local History Librarian at the Topeka & Shawnee County Public Library. In this capacity, I have assisted Delmar in his research efforts as well as conducted my own research of Nick Chiles.

Nick Chiles is a name that should be just as well known in Topeka as Cyrus K. Holliday or Author Capper. Chiles' accomplishments are as far reaching as theirs. Chiles' impact as an entrepreneur and a tireless advocate for African American's social and civil rights in Topeka and across the nation every citizen cannot be measured. He did this all by starting the longest running African American newspaper west of the Mississippi in 1899 here in Topeka.

Chiles made the trek to Kansas in 1886 from South Carolina. Known as a natural leader, he operated several businesses in Topeka which included; the first hotel for African Americans in the city, a restaurant, a 160 acre farm and skating rink. He found his real passion in 1899 when he started the small newspaper "Topeka Plaindealer". As the editor and publisher Chiles circulated the most popular newspaper for African Americans in the Midwest and beyond for thirty years. In an editorial published after his death it states that Chiles was "a consistent, militant attitude and fearless advocacy of full citizenship rights for every man stood him out as a champion of the race." Truly, he was an embodiment of values that all Topekans would be proud of.

As a public historian I am always seeking ways to take history out of the classroom and into people's everyday lives. This renaming of the 10<sup>th</sup> Street Bridge is a project that certainly exemplifies a way to do that. It is these visible reminders, such as a sign on a bridge, that bring history to the forefront every day. A history to be proud of. I hope the city will continue to seek out and support projects such as this one.

## Letter Supporting the Naming of the Nick Chiles Bridge

April 30, 2017

Dear Topeka City Council:

In the late 1800's and throughout the 1900's the Black Press was a premier form of communication for the Black community. In 1899, a new Topeka resident, Nick Chiles, found a way to educate, inform and entertain the Black community through his newspaper, the Plaindealer. Mr. Chiles was the owner and editor of the Plaindealer newspaper in Topeka, Kansas. His words brought information from state to state and was read by thousands. The contents of his paper opened the eyes of the community to the soul of the nation.

Mr. Chiles was a serial entrepreneur. He owned several businesses between 112 and 118 SE Seventh Street, including the Chiles Hotel.

Mr. Mayor, Mr. Manager and members of the Governing Body, thank you for the opportunity to address you this evening on this important topic.

My name is Patrick Woods and I'm here to declare my strong support for the proposal to rename the bridge that takes S.E. 10th Street over Brunner Road the Nick Chiles Bridge, in honor of the longtime publisher, entrepreneur and activist. As you have no doubt heard, Mr. Chiles left a legacy unmatched by many who have followed, though the works that constitute his legacy have benefited all of us.

Mr. Chiles made his way to Kansas in 1886 from the former confederate state of South Carolina. Following many African Americans who made their way west, seeking not only new opportunities to realize their full citizenship, but also seeking refuge from the discrimination and terrorism that had become all-too-common in the deep south, Mr. Chiles found his home

right here in Topeka. His days in the capital city are distinguished not only by the multiple successful businesses he operated, which include: the *Topeka Plaindealer*, which was the most widely circulated black periodical this side of the Mississippi; a restaurant; a hotel; and a skating rink for black Topekans. Rather, the true measure of Mr. Chiles's distinguished citizenship becomes clear once we consider his activism for the civil rights of black Americans. I don't have time to fully and adequately discuss all the change that was achieved due to Mr. Chiles's service — and no doubt you will have already read much of it in the written material submitted to the body, but I will say that history has proven Mr. Chiles's unyielding and self-sacrificing activism to have been effective in achieving change that has proved to be not only meaningful, but enduring.

Finally, the principal reason that I believe that this change should be made is because of what it can do for our young people. In my night life, I serve on our local school board. While I'm not addressing you on behalf of the board, but solely as a Topekan, I believe that it is critically important that we embrace efforts like this one -- whereby correcting historical omissions and completing our history, we make history more relevant to all of our young people, who are just at the age where they are beginning to form their world view. With this one, simple change we can correct an omission in Topeka's history by

placing the name of Nick Chiles in the public view, and we can equip our children with a more complete historical lens through which they can view our shared past, interpret the events of the present, and maybe (hopefully), even divine the future. You could inspire the next *Nick Chiles*.

For these reasons I urge you to approve the measure before you tonight. Thank you for your consideration of my comments and thank you for your service to our city.
